For instance, the Securities and Exchange Board of India (SEBI) mandates financial education in schools, targeting youth. However, rural areas face hurdles, with 45% of the population excluded from formal banking services. Government schemes like PMJDY have made strides, but implementation gaps remain. Microfinance institutions and selfhelp groups have made headway, aiding financial inclusion. Despite progress, regional disparities, diversity, and linguistic technological advancements pose challenges. Continuous efforts are crucial to bridge these gaps, ensuring comprehensive financial literacy across India's diverse populace. Financial literacy serves as the cornerstone for individuals to make informed decisions regarding financial products and services tailored to their needs. The SCRIPT framework -Saving, Credit. Remittances. Insurance, Pension, and Transactions - provides a

holistic view for financial inclusion. Mere possession of a basic savings account does not equate to financial inclusion, highlighting the importance of dispelling illusions through effective financial literacy (FL) awareness. At the grassroots level, lack of FL awareness poses a significant barrier for marginalized communities to access necessary financial products and services. Existing FL programs often operate in a "Hit & Run" mode, necessitating a shift towards sustained community engagement to induce strong attitudinal and behavioral changes. This requires additional resources and operating costs but is crucial for meaningful impact.

Furthermore, inclusive growth hinges on sensitizing all stakeholders, particularly bankers, about their role in facilitating financial integration. Bankers must understand community perspectives to ensure hassle-free access to financial services. Beyond traditional training methods, exposure to NGO initiatives broadens bankers' vision and enhances their ability to serve communities effectively. Similarly, orienting community leaders with NGO support accelerates the financial inclusion process.

Recognizing the complexity of comprehensive financial inclusion, a multi-stakeholder approach with a unified mission of inclusive growth is essential. Collaboration among stakeholders, including agencies, government financial institutions, NGOs, and community leaders, is critical to fostering a new social order conducive to the financial well-being of marginalized communities. This holistic approach ensures that financial literacy initiatives translate into tangible improvements in the lives of those most in need, driving sustainable development and prosperity at the grassroots level.

Enhancing Community Health through Capacity Building

Workshop on "Advancing Financial Inclusion for a New Social Order through Community-Led Financial Literacy Initiatives"

The Workshop on "Advancing Financial Inclusion for a New Social Order through Community-Led Financial Literacy Initiatives" held on February 3, 2024, at the Pune Symposium, aimed to address attitudinal issues and knowledge gaps among target communities, develop strategies to eliminate access barriers to financial services, and sensitize stakeholders about their roles in advancing financial literacy for rural communities' well-being.

The session commenced with an introduction by Mr M. Kathiresan, experienced banker and mentor of CFL initiatives emphasizing the crucial role of financial literacy in community development and the need to disseminate information on financial services while addressing existing barriers. SBI Officials, Mr. Naresh Sankhala and Mr. Uday Kulkarni, virtually participated in a guest lecture, highlighting the significance of financial institutions in enhancing literacy, particularly emphasizing digital transactions.

Sri Gurunathan, Director, The DHAN Academy in his address, emphasized collaborative efforts with banks for financial literacy initiatives and underscored the transformative impact of digital financial transactions. M. Santhanam, Program Officer introduced the 'GST' formula for community engagement, emphasizing discipline, awareness, and maintaining positive banking relationships. Mr C. Nagaraj, CFL Coordinator discussed the importance of financial literacy, government and RBI initiatives, and strategies for addressing regional imbalances in financial services.

Group discussions were conducted on various topics, including community engagement strategies, utilization of visual aids and local languages, educating students about financial services, and addressing attitudinal and behavioral changes within communities.

The workshop outcomes emphasized stakeholder collaboration to enhance financial literacy for inclusive community development, focusing on bridging knowledge gaps, removing access barriers, and promoting digital literacy and community engagement.

In addition, resolutions were passed, advocating for the post-program handholding of community members to induce attitudinal and behavioral changes and for sensitizing local bankers on their role in facilitating financial inclusion, with proposals for NGO involvement to better align banking practices with community needs.

Workshop on SUHAM Federations: A New Social Order for Community- Owned Healthcare Systems

The workshop, spearheaded by Mr. Nitin Khadake, Regional Coordinator of the Nanded Region and Project Executive of DHAN Foundation, marked a significant milestone in the pursuit of a transformative healthcare model. Resource persons include Mr. Rajapandian, Chief Executive Officer of SUHAM Federations; Mrs. T V Padmashankari, Programme Leader of DHAN Kalanjiam Foundation; and Mrs. Dipti Patgaonkar, Incharge of KVK, Beed Region. The assembly comprised DHAN Federation members, associates, Community Financial Literacy Centre coordinators, MIS representatives from diverse locations, and TDA students.

Commencing with a solemn prayer, the participants engaged in a comprehensive discussion on local food systems, prevalent health issues, healthcare preferences, and annual expenditure for family health. The discourse revealed that communities grapple predominantly with health issues such as hypertension, diabetes, thyroid disorders, and respiratory ailments. Strikingly, the primary recourse for healthcare services was local Primary Health Centers (PHCs), though major health concerns often led them to private hospitals, resulting in substantial financial burdens, often reaching lakhs.

Ms. Dipti Patgaonkar, In-charge of Krishi Vigyan Kendra (KVK), Beed Region, enlightened the audience on the manifold benefits incorporating millets into their dietary regimen. Emphasizing the cultivation and production she detailed effective marketing processes, strategies. Consumption of millets, she elucidated, not only offered delectable culinary options but also delivered essential nutrients, serving as a preventive measure against ailments such as anemia.

Mr. Nitin Khadake then presented the visionary concept of the Community-Owned Healthcare System under the aegis of SUHAM Federations. Three key divisions - Community Health & Nutrition (CHN), Sanitation & Safe Drinking Water (SAWAS), Medical Care and Diagnostics (MCD) - formed the crux of this pioneering initiative. The scope, status, and functional systems, as well as the current scenario, were meticulously outlined. The multifaceted role of SUHAM Federations encompassed training and capacity building, resource mobilization, product promotion, mainstream linkage for entitlements, experimentation, pilots,

documentation, and ensuring last-mile reach through social capital. The imperative focus areas were elucidated, underscoring the need for concerted efforts.

Mr. Rajapandian, Chief Executive Officer (CEO) of SUHAM Federations, delineated the five primary benefits of affiliating with SUHAM Federation. These included comprehensive health awareness programs, free consultations with a doctor for a year at a nominal cost of Rs 300, significant discounts on medicines, laboratory tests, and surgeries at MOU-signed hospitals. The practicality of these benefits was demonstrated through real-life examples, reinforcing the potential for income generation by forming federated hospitals.

Mrs. T V Padmashankari, Programme Leader of DHAN Kalanjiam Foundation, encouraged participants to express their willingness to engage with SUHAM and proposed tentative dates for initiation. Importantly, she shared valuable experiences, emphasizing that members need not incur additional costs for enrollment, and suggested leveraging mobile vans as a strategic approach to community service.



In a pivotal moment, Mr. A Gurunathan, Programme Leader of DHAN Foundation, advocated for participation in DHAN Yatra in March, providing a firsthand experience of the impactful programs in Madurai covering health, insurance, Jeevidham, KDFS, and education. He urged leaders to instigate discussions and seed the concept during meetings, emphasizing the need for proactive measures.

The commitment to action was palpable, with the Kandhar Region Coordinator, along with associates and leaders, pledging to register the SUHAM Federation by May 2024. Their strategic approach involved expanding groups and memberships, followed by cluster-level meetings to disseminate the concept widely. From the Hingoli Region, a commitment to securing external funds and inspiring community donations underscored the collective dedication to the cause.

Concluding the session, Mr. Nitin expressed gratitude for active participation, urging participants to share their learnings over the two days with fellow members. The imperative to apply newfound knowledge in the field for tangible benefits resonated as a call to action.
